General Instructions to Applicants

1. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of application failing which their application may be rejected.
2. Each post carries allowances according to the Indian Floorball Federation's rules & regulations.
3. Applicants are advised to ensure, before applying, that they possess at least the minimum essential qualification and experience laid down for the post.
4. Age, qualification and experience will be calculated on the closing date of online submission of applications.
5. The applicants should be certified as national coach of the Indian Floorball Federation (should have passed national and/or international seminar for coaches).
6. The Federation reserves the right to:
 - a. Hold Written Test, Skill Test, Presentation and/or Interview for selection, whenever circumstances so warrant;

- b. Withdraw any advertised post(s) at any time without giving any reason. Also, any consequential vacancy arising at the time of interview may be filled up from the available candidates. Thus, the number of positions may change;
 - c. Offer the post at a level lower than that advertised, depending upon the qualifications, experience and performance of the candidate.
7. The prescribed Essential Qualification and Experience indicated are a bare minimum; mere possession of same will not entitle applicants to be called for Test or Interview.
 8. Applicants have to pay a non-refundable application fee of Rs. 200 for the post.
 9. Candidates are required to pay requisite fee of the post. The responsibility of entries in the application form lies with the Applicant. If any declaration given or information furnished by the applicant proves to be false, or found wilfully suppressed any material information, the candidate shall be liable for removal from service at any stage of the employment.
 10. Applications submitted without the valid 'NOC' on the state association letter head, from the state secretary shall not be accepted.
 11. The InFF reserves the right to relax age, qualifications and/ or experience in exceptional cases, or in case of persons already holding any positions in the Federation, etc.
 12. The numbers of vacancies indicated in the notification are tentative. InFF reserves the right to increase or decrease the number or NOT to fill any of these post(s) advertised.
 13. Submitting the application form and paying fee should be done only through the online process. Applicants are advised to keep a copy of submitted application form (you'll get the response submitted on your registered email) and fee receipt for future reference.
 14. Canvassing in any form or bringing in any influence political or otherwise, will be a disqualification for the post.
 15. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the InFF reserves the right to modify, withdraw or cancel any communication made to the Applicants.
 16. After joining the service of the InFF, the coach(s) will have to abide by the Rules, Regulations, Ordinances, Statutes and Act of the Federation applicable from time to time.
 17. The InFF shall verify the antecedents or documents submitted by a person at the time of document verification, appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake, or the person has a clandestine antecedents or background and has suppressed the said information, then his/her services shall be terminated forthwith.
 18. The Decision of the Federation shall be final and binding. It can't be challenged at any forum.
