- * **For Trials:** Please bring 1 currently valid identity proof in original for the verification of Date of Birth. - **THIS IS MANDATORY FOR EVERY PLAYER.** Currently valid identity proof may be Aadhaar Card/ E-Aadhaar Card with a photograph/Passport/10th Certificate/Birth Certificate issued by State or Central government. Please Note - Any other document (except aforementioned) will NOT be accepted as valid ID proof for this purpose. No player without a valid age proof will be permitted to participate.
- * **It's mandatory for everyone to produce the proof of both covid-19 test (RTPCR) negative report and at least had one does of either Covaxin, Covishield or any other vaccine approved by Government of India.**
- * RTPCR test negative report shouldn't older than 72 hours. Entry is prohibited without the RTPCR test negative report.
- * Only RTPCR test report is acceptable. Any test reports other than RTPCR, won't be accepted.
- * Only the players born after 25th August 2006, 11:59 PM are eligible to participate in trials.
- * For Trials, preference will be given to the players who either took part in Mangalore camp, Goa camp or Dehradun Camp.
- * Apart from those players who participated in either of the camps, State secretary can recommend more players who interested and talented to give trials. Please recommend only those players who have participated in any 2 consecutively national tournaments. And they must meet the physical and skill level of the India camp players. No newcomers or beginner players will be allowed for trials.
- * The fee submitted and name recommended without consulting the undersigned, won't be refunded back and taken into consideration respectively.
- * State Secretary must contact undersigned for the availability of seats, as they are limited, and for any other queries related to the player recommendation, fee submissions, etc.
- * If any player is found guilty of providing wrong information, he/she will be suspended from the game for 2 years and appropriate action will also be taken against the official of the state unit.
- * It's **highly recommended to attend the online meeting** before you take any action. The online meeting is scheduled on **12th August, 2021 at 12:30 PM**. The meeting will be held at google meet and the link will be given at **12:15 PM on the InFF WhatsApp secretary group**.

Maximum Team Official Allowed:

1. From a state; More than or equal to 6 players – one male & one female or 2 female officials. Less than 6 players – either one male or one female official.

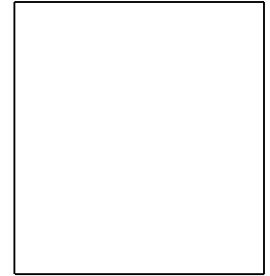
